ORDINANCE NO. 2021- 025

AS AMENDED

AN ORDINANCE AMENDING TITLE 4 OF THE DELAWARE COUNTY CODE REGARDING PERMIT FEES

FOR SOLAR FARMS, SOLAR INSTALLATIONS AND FLOODPLAIN DEVELOPMENT AND FOR THE DISTRIBUTION OF FEE REVENUE

- **WHEREAS,** the Board of Commissioners, in accordance with state statutes, may adopt building and permitting ordinances that include reasonable fees for permits, registrations, renewals, inspections and re-inspections; and
- WHEREAS, comparison data on permit fees was collected from other counties for solar farms; and
- WHEREAS, there is no listing for solar farm permits fees which are usually specific to that use only and the Permit Fees section of Title 4 should be supplemented with that type of fee as well as individual commercial solar installations; and
- WHEREAS, there is a need to add a permit fee for a Floodplain Development permit as required by the Floodplain Management Ordinance of Delaware County, Indiana; and
- WHEREAS, there is also a need to provide a source of revenue for the Unsafe Building Fund to implement the requirements of the Delaware County Unsafe Building Ordinance and the Delaware County Unincorporated Abatement of Vacant & Abandon Structures Law; and
- WHEREAS, there is a desire to maintain an efficient and professional county building department that is self-sufficient through the payment of appropriate and competitive permit fees.

NOW, THEREFORE, BE IT ORDAINED by the Board of Commissioners of Delaware County, as follows:

Section 1. That Title 4, Chapter 2 Permit Fees, shall be supplemented by inserting new listings for solar farms and individual commercial solar installations, and by inserting a new Item 10 for floodplain development, as follows:

Section 2. That the following phrase "MINIMUM \$200, MAXIMUM \$1,000.00" under Section 4-2-7. Electrical Permit Fees, Item 2(c) Commercial and Industrial: New Construction, shall be deleted so that Item 2(c) reads as follows: Inspection fee for 1000 AMP and up is \$200.00 plus \$6.00 per 100 sq. ft.

Section 3. That a new Item 11 shall be inserted to allow for a percentage of all permit fees to be deposited into the Unsafe Building Fund (Fund #1207), as follows:

4-2-11. Distribution of Fee Revenues.

For all fees collected under Title 4, Chapter 2 of the Delaware County Code, ninety percent (90%) of the fee revenues shall be deposited into the Delaware County General Fund and ten percent (10%) shall be deposited into the Delaware County Unsafe Building Fund (Fund #1207).

Section 4. That the existing Items 4-2-10 through 4-2-12 shall be re-codified as 4-2-12-through 4-2-14.
