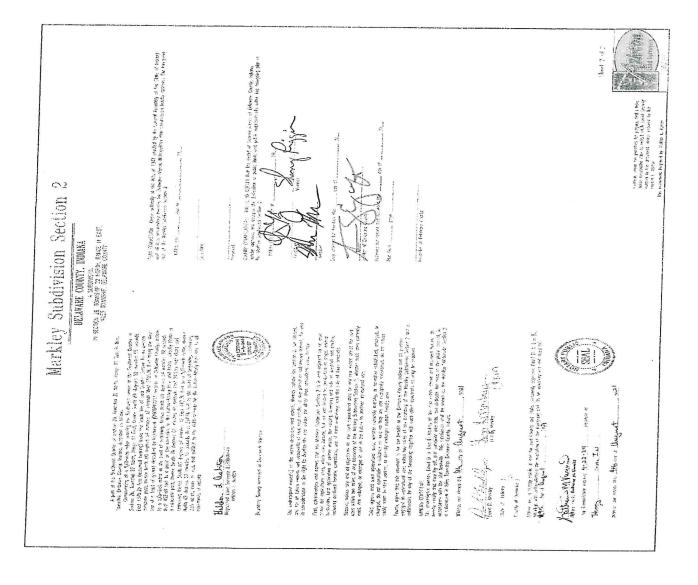
PLAT APPROVAL FOR MARKLEY SUBDIVISION - ASHTON LAND SURVEYORS

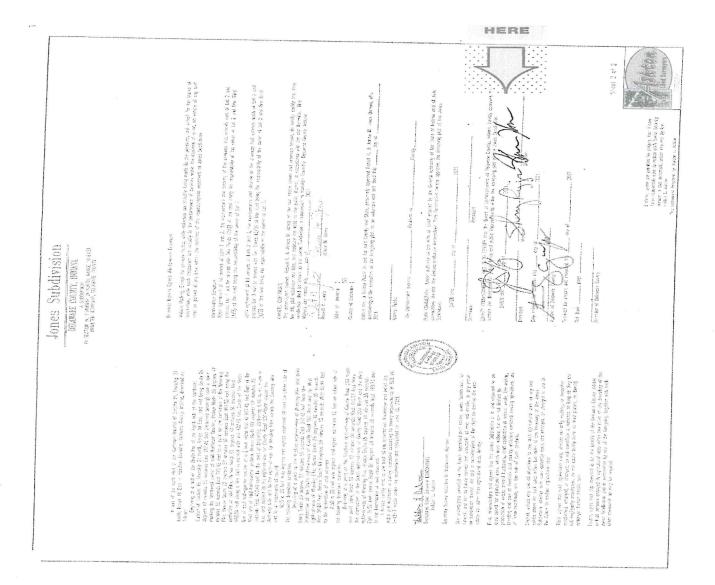

AGREEMENT FOR COLLECTION OF ACCOUNTS ATLAS

Ms. Emily Anderson, Court Administrator and Mr. Jeff Hansard, Chief Probation Officer, presented the agreement with Atlas Collections. The Probationers are no longer on probation. They leave supervision owing probation fees, court costs and/or restitution. Approximately \$250,000 is owed to the county. Probation department no longer has an address and cannot find the probationer to be able to collect the fees. Atlas adds a 30% fee to the probation fees due to the county.

Any payment received is split between County and Atlas, approximately 70% (County) and 30% (Atlas). MOTION: Commissioner Henry made a motion to approve agreement with Atlas Collections.

AGREEMENT FOR COLLECTION OF ACCOUNTS

DELAWARE COUNTY COURTS FEES (CLIENT) hereby engages ATLAS, not as an employee or agent, but as an independent contractor, to undertake collection of certain accounts receivable and ATLAS agrees to pursue collection of such accounts, subject to the following terms and conditions:

I. ACCOUNT LISTING

The accounts shall be submitted to ATLAS on a regular schedule as determined by the DELAWARE COUNTY COURTS PEES (CLIENT).

2. ACCOUNTS TO BE COLLECTED

Under this Agreement, DELAWARE COUNTY COURTS FEES (CLIENT) agrees to submit only those accounts that are in default for Regular Collection efforts.

3. LEGAL ASSIGNMENT

ATLAS shall not initiate legal proceedings on any account without prior authorization by a designated individual or individuals by DELAWARE COUNTY COURTS FEES (CLIENT). All attorney fees incurred with legal collections proceedings will be the responsibility of ATLAS. Court costs expenses are the responsibility of the DELAWARE COUNTY COURTS FEES (CLIENT). Arrangements can usually be made with the local courts to defer these until collections are made on these accounts with judgments attached.

4. COMPROMISE OR SETTLEMENT

ATLAS shall make no compromise or settlement without approval from designated individual or individuals as selected by DELAWARE COUNTY COURTS FEES (CLIENT).

5. COMPLIANCE

All activities by ATLAS shall comply with all applicable federal, state, and local laws, ordinances, rules and regulations. Further, all activities of ATLAS shall adhere to the policies and procedures of the INDIANA COLLECTORS ASSOCIATION, INC. and the AMERICAN COLLECTORS ASSOCIATION, INC. of which ATLAS is a member in good standing.

RESOLUTION NO. 2021-021

RESOLUTION OF BOARD OF COMMISSIONERS APPROVING THE ISSUANCE OF BONDS

WHEREAS, the Delaware County Redevelopment Commission ("Commission") has determined to issue its Redevelopment District Refunding Revenue Bonds, Series 2021 ("Refunding Bonds"), in the aggregate principal amount not to exceed \$3,000,000, to finance the cost of refunding its outstanding Redevelopment District Bonds, Series 2012, dated June 26, 2012 ("Refunded Bonds"), including incidental expenses incurred in connection with the refunding of the Refunded Bonds including funding a debt service reserve and premiums for a debt service reserve surety and municipal bond insurance, if necessary, and costs associated with the issuance of the Refunding Bonds pursuant to the Commission's resolution adopted on August 12, 2021 ("Bond Resolution");

WHEREAS, the Refunding Bonds will be payable solely out of Tax Increment and, to the extent Tax Increment is not sufficient, the Special Benefits Tax (each as defined in the Bond Resolution), allocated and deposited as provided in the Bond Resolution; and

WHEREAS, the Board of Commissioners of the County is required by IC 36-7-14-25.1(p) to approve the issuance of the Refunding Bonds; and

WHEREAS, pursuant to IC 36-7-14-25.1(c), the public purpose of the Refunding Bonds is to finance the refunding of the Refunded Bonds to achieve a savings which savings will be used in one or more of the following ways: (a) to fund a debt service reserve for the Refunding Bonds; (b) to pay debt service on the outstanding obligations; or (c) reduce the amount of Tax Increment needed annually to pay debt service on the Refunding Bonds, all pursuant to IC 51518(b);

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF DELAWARE COUNTY, INDIANA, THAT:

- 1. The Board of Commissioners hereby approves the issuance of the Refunding Bonds in an aggregate principal amount not to exceed \$3,000,000 at a purchase price of 100% of the par value thereof, with a term ending no later than February 1, 2030, and a maximum interest rate of five percent (5.0%) per annum (actual rates will be determined by negotiation).
- 2. The Bonds shall be issued in denominations of \$5,000 or \$1,000 and integral multiples thereof, respectively, or minimum denominations of \$100,000 and multiples of \$1,000 thereafter, or as determined by the Auditor with the advice of the County's municipal advisor and bond counsel. The Bonds shall be payable upon presentation at the office of the Paying Agent (as defined in the Bond Resolution) or at the principal

- 3. The Bonds are redeemable at the option of the Commission, but no sooner than five years after their date of issuance, on thirty (30) days' notice, in whole or in part, in the order of maturity as determined by the Commission and by lot within maturities, at face value, together with no premium, plus accrued interest to the date fixed for redemption, and may be subject to mandatory sinking fund redemption as determined upon the sale of the Bonds.
- This resolution shall be in full force and effect from and after its passage.

RESOLUTION NO. 2021- 029

RESOLUTION OF THE DELAWARE COUNTY BOARD OF COMMISSIONERS TO JOINTLY UNDERTAKE AN ECONOMIC DEVELOPMENT PROJECT WITH THE TOWN OF YORKTOWN, INDIANA PURSUANT TO IND. CODE \S 36-7-25-1 *ET SEQ*.

WHEREAS, the Delaware County Board of Commissioners (the "Commissioners") serves as the legislative body of Delaware County, Indiana; and

WHEREAS, the County has previously established a department of redevelopment controlled by the Delaware County Redevelopment Commission and subject to oversight by the Commissioners; and

WHEREAS, the Delaware County Redevelopment Commission has established certain allocation areas within various economic development areas throughout the County, which receive property tax revenue from properties located within these allocation areas; and

WHEREAS, the Board of Commissioners of Delaware County believe that it is in the best interest of the County to work with the Town of Yorktown on their economic and quality of life projects; and

WHEREAS, the Board of Commissioners express a desire to have a long-term relationship with the Town of Yorktown officials for the overall improvement of the County; and

WHEREAS, the Town of Yorktown, Indiana (the "Town") has submitted a proposal to the Commissioners to jointly undertake economic development projects within the Town that will serve or benefit both units' jurisdictions; and

WHEREAS, Delaware County has some economic development areas in the Town of Yorktown which could be utilized for the benefit of Yorktown economic and quality of life projects; and

WHEREAS, the Commissioners now desire to enter into discussions with the Town regarding an agreement to jointly undertake economic development projects within the Town pursuant to the provisions of Ind. Code § 36-7-25-1 et seq. according to the general parameters stated herein.

NOW THEREFORE BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF DELAWARE COUNTY, INDIANA:

- The Delaware County Board of Commissioners, through its duly appointed designee(s), shall engage in discussions with the Town to establish the terms and conditions of an agreement to jointly undertake the proposed project within the Town pursuant to the provisions of Ind. Code § 36-7-25l et seq.
- 2. The Board of Commissioners pledge to work together and enter agreements with the Town to jointly undertake economic development projects within the Town shall contain those terms and conditions which are in the best interest of both the Town and the County, but shall be subject to the following limitations:
 - a. The agreement shall be conditioned on the Town's willingness and ability to amend any and all applicable economic development plans to ensure the Town is properly authorized to engage in a joint project with the County.

- The agreement shall also be reviewed and approved by the Delaware County Redevelopment Commission.
- c. The Board of Commissioners shall work with the Town of Yorktown and the Delaware County Redevelopment Commission to assist in funding the economic development project in the Town of Yorktown in amounts not to exceed One Hundred Thousand and 00/100 (\$100,000.00) Dollars during the term of the agreement. The County's assistance towards this project shall be funded exclusively from allocation area revenue received by the Delaware County Redevelopment Commission.
- d. The agreement shall only obligate the County to pledge revenue from those allocations area(s) within the jurisdiction of Delaware County that are contiguous to the allocation area(s) within the jurisdiction of the Town of Yorktown.
- A proposed agreement with the Town to jointly undertake economic development projects within
 the Town shall be subject to final approval of, and execution by, the Commissioners and the
 Redevelopment Commission before such agreement may become effective.
- 4. The Commissioners shall not approve a final proposed agreement with the Town to jointly undertake economic development projects within the Town unless the Commissioners specifically find that the economic development projects described in the agreement will serve or benefit the County's applicable allocation areas.
- 5. This Resolution shall be effective upon adoption.
