

## RESOLUTION NO. 2021- 057

## A RESOLUTION OF THE DELAWARE COUNTY COUNCIL TO AMEND 2022 BUDGET APPROPRIATIONS (COUNTY GENERAL FUND 1000 -DEPARTMENT 157 COUNCIL)

WHEREAS, the Delaware County Council ("Council") has previously approved the annual budget and appropriated funds from the County General Fund 1000 - Department 157 Council for the calendar year 2022; and

WHEREAS, the Council believes that the budget and appropriation should be amended by reducing certain line items within its department and increasing one line item by the same amounts; and

WHEREAS, the proposed amendments will not change the overall General Fund budget and the total appropriation for Department 157 Council for 2022; and

WHEREAS, the Council has been advised by the Indiana State Board of Accounts and the Indiana Department of Local Government Finance that it has the authority to make the proposed amendments by the adoption of this Resolution;

NOW, THEREFORE, BE IT RESOLVED BY THE DELAWARE COUNTY COUNCIL AS FOLLOWS:

1. The 2022 budget and appropriations from the County General Fund 1000 - Department 157 Council shall be amended as follows:
