COMMISSIONERS OF DELAWARE COUNTY

WHEREAS, IC §8-12-4-9 authorizes the abandonment of surplus rights-of-way by the Indiana Department of Transportation; and

WHEREAS, IC §8-23-2-6 and the Commissioners of Delaware County authorize the Indiana Department of Transportation to abandon and dispose of property and to execute all instruments to carry out their responsibilities; and

WHEREAS, certain parcels at a location on Old State Road 3 near the Muncie Bypass were acquired by Indiana Department of Transportation for construction of roadways and/or utilities; and

WHEREAS, the parcels will not be needed for roadway or utility purposes incidental thereto, now or within a reasonable time in the future; and

WHEREAS, the Indiana Department of Transportation is the sole owner of said parcels; and

WHEREAS, the parcels being abandoned and vacated herein are described on the attached exhibits; and

BE IT HEREBY RESOLVED that the Commissioners approve the abandonment of such parcels and request the Indiana Department of Transportation to abandon and relinquish the parcels to Second Harvest Food Bank of East Central Indiana.

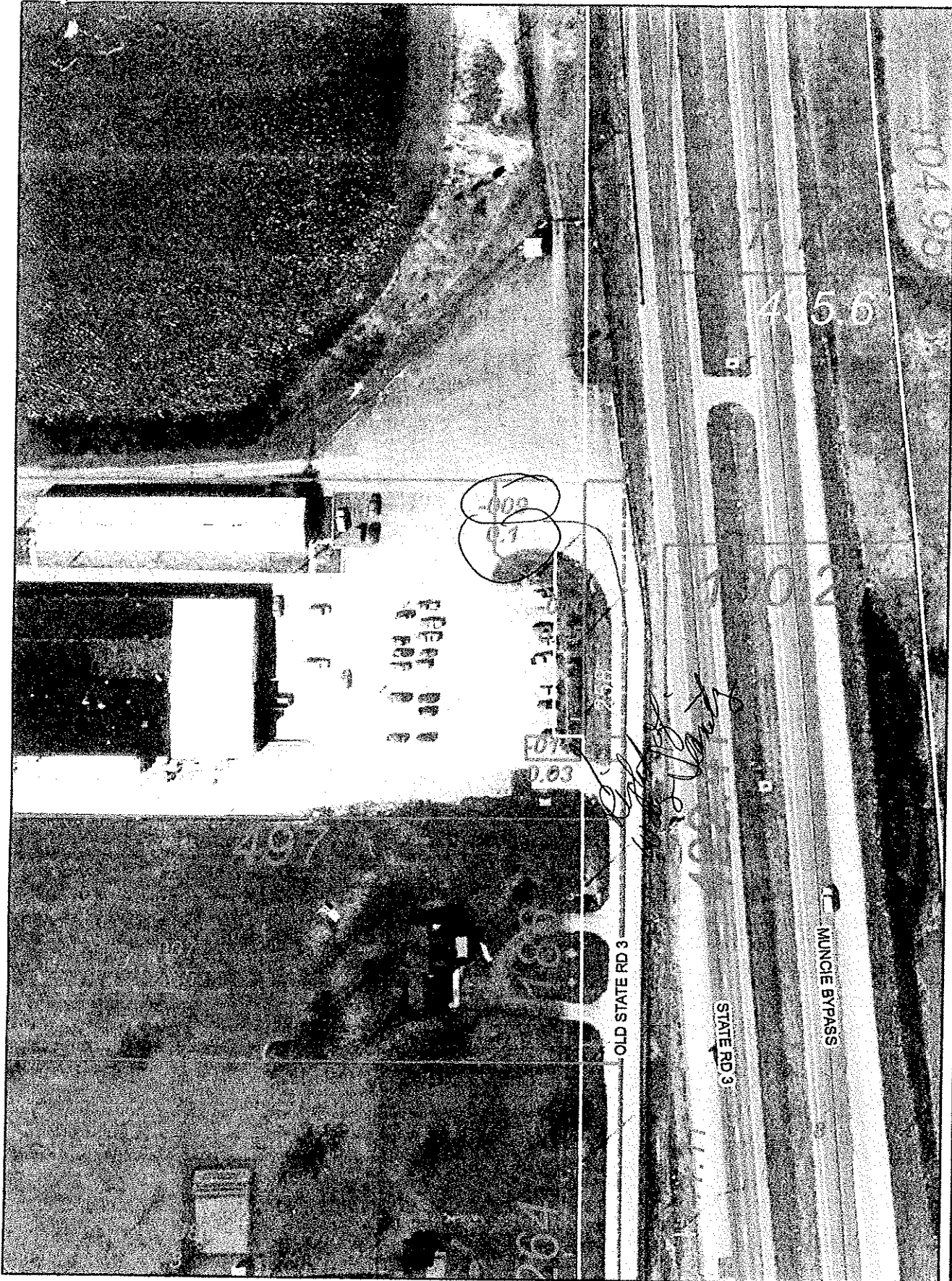

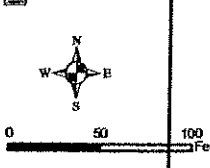
