TRANSIT UPDATE'S



MITS: has started replacing its paratransit van fleet by purchasing propane-powered vans. The purchase of such a van using FY 2015 FTA funds has been planned. MITS has also planned for propane refueling tank/equipment on their property.

MITS: everything is in place to use FY 2015 STP federal funds flexed to FTA toward sidewalk improvements in downtown Muncie. The proposed sidewalk improvements are consistent with the City's ADA Plan for making sidewalks accessible to those with disabilities.

New Inter-Urban Rural Transit Service Fare Structure: The multi-county transit service provided by LifeStream Services has experienced a slight decrease in ridership in spite of changing the fare-structure to encourage people to ride. The change to lower single fares and dropping monthly passes helps to encourage more people to try the transit service and possibly increase trips.

Hillcroft Services: Hillcroft is pursuing an FTA Section 5310 grant for the purchase of transit vans to use in Delaware County and the region nearby. The non-profit provision of transportation is helped by securing and replacing the vans so the fleets used for travel to programs don't disappear by attrition.

RIVERSIDE AVENUE PEDESTRIAN CONCERNS

A meeting of the Westview Neighborhood was held on February 11, 2015. An item of concern discussed was the presence of speeding cars in a street section that has bike and pedestrian traffic, especially children.

The possibility of a speed table, a flashing pedestrian crossing and other ideas were discussed as possible solutions to the dangers existing there. The need for sidewalks along Riverside Avenue to separate pedestrian traffic from car traffic was noted.



A speed table is a raised segment of road around twenty feet in length that encourages traffic to slow down to 20-25 mph when tires bump into it and drop off of it. Such a reduced-speed table can be made more effective if it doubles as a pedestrian crosswalk. The City is planning to take a closer look at the options mentioned, design safety improvements for the area, and bring the proposed improvements back to the Westview Neighborhood Association for more input.

FY 2016-19 DELAWARE MUNCIE TRANSPORTATION IMPROVEMENT PROGRAM

Work has begun toward the development of an FY 2016-19 Delaware Muncie Transportation Improvement Program (DMTIP). Information on continuing projects, desired projects and financial information is being collected to use in this document. An April 9th public meeting in the Commissioners' Courtroom at 5 pm, the April 9th Technical Advisory Committee 10 am meeting in the County Building and the April 15th meeting of the Transportation Policy Committee at 1:30 pm the Mayor's Office will provide an opportunity for public input. The May committee meetings will be used to complete the project selection, prioritizing and local approval process.

2016 - Reconstruct Neely Ave from New York Ave to Wheeling Avenue.

- Intersection and enhancement improvements for Nebo Road at SR 332.
- Construct a roundabout for Jackson Street at Nebo Road.
- Construct bicycle /pedestrian trail along River Road west of Morrison Road.
- Construct trailhead, boardwalk, an ATV area, for a trail at Prairie Creek Reservoir.

- Rehabilitation of Bridge #161, CR 170S over White River.
- Sign replacement for the Town of Eaton to meet FHWA sign retro-reflectivity requirements.

2018 - Extend Everbrook Lane from SR 332 to Bethel Avenue, including new sidewalks.

Bridge #141, Tiger Drive over White River: bridge rehabilitation and bicycle/ pedestrian path.
Trail work near SR 32 for White River Corridor & Cardinal Greenway bicycle /pedestrian trails.

2019 – Reconstruct Wheeling Avenue from Riverside Avenue to Centennial Avenue.
