WHEREAS, the COUNTY shall provide to INDOT information regarding anticipated construction permits related to the commercial development, which shall include any traffic projections related to each anticipated commercial use; and

WHEREAS, the COUNTY agrees to perform a traffic signal analysis at the intersection of the driveway approach with S.R. 28 upon INDOT's request; and

WHEREAS, INDOT may require COUNTY and its successors, or assigns to design and install a traffic signal at the above location when the minimum traffic volume warrants the installation of a traffic signal; and

WHEREAS, INDOT may require COUNTY and its successors, or assigns to design and construct auxiliary lane(s) at the above location when the minimum traffic volume warrants the installation of auxiliary lane(s); and

WHEREAS, the COUNTY and its successors, or assigns, agree to dedicate any necessary right-of-way needed for the construction of auxiliary lane(s) and/or traffic signal and equipment if

WHEREAS, the COUNTY shall be responsible for the costs of the warrant analysis, costs associated with the design and installation of a traffic signal, cost of construction of traffic signal and appurtenances, costs of construction of auxiliary lane(s), costs to acquire any required right-

INTERLOCAL COOPERATION AGREEMENT BETWEEN THE TOWN OF YORKTOWN AND DELA WARE COUNTY FOR STREETS AND ROADS MAINTENANCE AND IMPROVEMENTS

THIS INTERLOCAL COOPERATION AGREEMENT (hereinafter "Agreement") is entered into on this day of 2018 but effective as of January 1, 2019 by and between the Town of Yorktown, Indiana ("Town") and the Board of Commissioners of the County of Delaware, Indiana ("County").

WITNESSETH THAT:

WHEREAS, IC 36-1-7 provides for the joint exercise of governmental powers and entering into voluntarily an agreement providing for such powers; and

WHEREAS, pursuant to IC 36-1.5 et seq., Mount Pleasant Township and the Town adopted mirror resolutions and an ordinance, effective June 23, 2011 ("Plan of Reorganization"), to reorganize their respective units into the Town ("Reorganization"); and

WHEREAS, the Plan of Reorganization adopted by Mt. Pleasant Township and the Town was approved by the respective voters of each unit on November 8, 2011; and

WHEREAS, the Plan of Reorganization contemplates and Indiana law requires an Interlocal Cooperation Agreement in order to evidence any agreements on duties and responsibilities for streets and road maintenance and improvements.

NOW, THEREFORE, pursuant to IC 36-1-7-2 and in consideration of the mutual promises and consideration contained herein, the parties hereby agree as follows:

ARTICLE 1. TERM

The term of this Agreement shall be from January 1, 2019 until December 31, 2022. This Agreement shall automatically renew for additional four (4) year terms upon the expiration of the then current term. However, either party may avoid automatic renewal of this Agreement by providing the other with written notice of termination at least ninety (90) days prior notice to the other party. 1.01

ARTICLE 2, PURPOSE

In addition to the background described in the recitals set forth above, the Town and the County desire to cooperate in the reorganization of the Town, with respect to providing street and road services in the Rural District of the reorganized Town. Representatives of Mt. Pleasant Township and the Town have served on the Transition Committee and have met with representatives of the County to discuss, plan and agree upon the terms of working cooperatively in allocating which governmental body shall provide road and street services in the Rural District following the Effective Date of the Reorganization. It is the understanding, intent, and agreement of the Town and the County to work cooperatively toward continuing to provide similar levels of road and street services in and to the Town and Rural Districts, as such services have been and are currently being provided in such areas prior to the Effective Date of the Reorganization. As the provision of road and street services are governed by Indiana law in IC Title 8, each of the Town and the County shall continue to observe and comply with Indiana law relative to providing road and street services to their respective areas of jurisdiction within the reorganized Town. 2.01

- · Emergency call outs for issues/failures/malfunctions other than periodic inspections

Payment for Services Rendered

The Client shall pay the Provider for services rendered according to the Payment Schedule attached, within 30 calendar days of the date on any invoice for services rendered from the Provider.

This contract shall be governed by the laws of the County of Delaware in the State of Indiana and any applicable Federal law.

ORDINANCES FOR SECOND READING

AN ORDINANCE ESTABLISHING A MORATORIUM ON CERTAIN USES WITHIN FARMING ZONES IN DELAWARE COUNTY, INDIANA

ORDINANCE NO. 2018-004

Mr. Brooke said Ordinance 2018-004 was heard and introduced on May 14, 2018 at the Plan Commission meeting. The one year moratorium will be amended to October 1, 2018. This would require the Plan Commission to make a decision on the CAFO regulations.

MOTION: Commissioner Riggin made a motion to adopt, as amended, Ordinance 2018-004, establishing a Moratorium on Certain Uses within Farming Zones in Delaware County.

This does not include the Light permits that have been granted.

Mr. Brooke said Mr. Light has received all local permits from Delaware County and would take effect upon adoption.

ORIGINAL

AN ORDINANCE ESTABLISHING A MORATORIUM ON CERTAIN USES WITHIN FARMING ZONES IN DELAWARE COUNTY, INDIANA

WHEREAS, the State enabling act for planning and zoning empowers the Board of Commissioners of Delaware County, Indiana to adopt a zoning ordinance which may, in each district, regulate how real property is developed, maintained, and used; and

WHEREAS, agriculture remains an essential component of Delaware County's economy and, through technology and market trends, agricultural activities dealing with animal feeding operations have increased; and

WHEREAS, Article XII of the Delaware County Comprehensive Zoning Ordinance currently provides that an animal feeding operation of any size is considered a permitted use in any F Farming Zone and a building permit may be issued provided the minimum requirements applicable to all farming uses are met; and

WHEREAS, there is a need to develop additional requirements and regulations applicable to animal feeding operations of a certain size and intensity to achieve and secure positive benefits while avoiding and/or minimizing adverse impacts; and

WHEREAS, in recognition of the significance of this matter in light of the questions and concerns raised by residents of Delaware County, the Board of Commissioners has determined it is necessary to establish a temporary moratorium on new applications for these uses until appropriate regulations can be identified and implemented in order to protect and provide for the public health, safety, and general welfare of Delaware County residents and visitors; and

WHEREAS, it is recognized that any uses that may be affected by the moratorium for which a complete application for a building permit has already been filed as required by the current Ordinances prior to the effective date of a moratorium must be allowed to complete the approval process and be placed in operation pursuant to Indiana Code § 36-7-4-1109; and

WHEREAS, after proper consideration of this matter, including receiving input from the public, the Delaware-Muncie Metropolitan Plan Commission has given its recommendation on the implementation of this moratorium; and

WHEREAS, reasonable regard has been given to the comprehensive plan; current conditions and the character of current structures and uses in each district; the most desirable use for which the land in each district is adapted; the conservation of property values throughout the jurisdiction; and responsible growth and development.

NOW, THEREFORE, BE IT ORDAINED, by the Board of Commissioners of Delaware County, Indiana, that:

SECTION 1: Moratorium Established.

The approval of building permits for any new or expanded Confined Feeding Operation (CFO), as defined in 327-IAC 19-2-7, or Concentrated Animal Feeding Operation (CAFO), as defined in 40CFR § 122.23, in Delaware County is prohibited until October 1, 2018 or until repealed by an ordinance establishing appropriate rules and regulations for animal feeding operation within the County, whichever occurs first.

SECTION 2: No severability.

No provision of this Ordinance shall be severed from any other provision or provisions of this Ordinance. If any single provision of this Ordinance is held unconstitutional or invalid, the entire Ordinance shall also be deemed unconstitutional or invalid.

SECTION 3: Repealer.

All other Delaware County ordinances shall remain in full force, except, any ordinance in conflict with the provisions herein shall be superseded and of no effect unless this Ordinance is repealed, expires, or invalidated.

SECTION 4: Effective Date.

This Ordinance shall take effect upon adoption and publication as required by law.


