Subject: Press Release – Surrender to Freedom Program
Date: January 9, 2019

The Delaware County Prosecutor's Office, in conjunction with the Delaware County Circuit Court Judges, the Muncie City Court Judge, the Muncie Mission and Road to Redemption is pleased to announce Surrender to Freedom, a warrant surrender program.

There are times when individuals who are dealing with substance abuse or addiction issues do not seek out appropriate treatment, partly because of fear of being arrested for an outstanding warrant due to an ongoing criminal matter. Our office hopes to eliminate that hurdle for those individuals who are serious about getting the help they need. The goal of this program is to give these individuals a chance to seek the treatment that they need to help combat this problem.

If a person has an active, qualifying bench warrant issued out of Delaware County, they may present themselves to the Muncie Mission, located at 1725 S. Liberty Street in Muncie on January 14, 2019 from 10:00 am to 6:00 pm. The person will not be arrested. Rather, they will be given a date and time to appear in court where the Judge of that Court can formally vacate the warrant and set new dates in the case. Additionally, if the person is suffering from drug or alcohol addiction, there will be advisors and treatment providers on site at the Mission to help with placement in available treatment programs.

It is our hope that those who have qualifying active arrest warrants will take advantage of this opportunity to have their warrants vacated to start 2019 off on the right foot. Even though the warrant will be vacated, the person will still have to deal with the underlying case. This program simply vacates qualifying warrants to provide the person an opportunity to deal with their pending case.

A warrant qualifies for this program if:

- 1) The warrant was issued by a Delaware County Circuit Court or the Muncie City Court;
- 2) The warrant falls under one of the following categories:
 - a. Warrants issued for Failure to Appear (FTA) at a previously scheduled court hearing;

- b. Arrest Warrants issued for non-violent offenses classified as Level 3 Felony or below; OR Class C Felony or below;
- c. Warrants issued out of Drug Court or Veteran's Court for Failure to Appear at a previously scheduled Review Hearing; or
- d. Warrants issued pursuant to a Probation Revocation where the ONLY violations are failure to report and/or failure to pay fees.

The following warrants **do not** qualify for participation in the Surrender to Freedom Program:

- 1) Arrest Warrants issued for any violent crime, which include, but are not limited to:
 - a. Battery (all types and classifications);
 - b. Rape;
 - c. Child Molestation;
 - d. Murder;
 - e. Arson;
 - f. Robbery;
 - g. Leaving the Scene of an Accident resulting in Death or Serious Bodily Injury;
 - h. Operating While Intoxicated Resulting in Death or Serious Bodily Injury;
- 2) Civil Warrants (Body Attachments);
- 3) Tax Warrants; and
- 4) Warrants issued pursuant to a Contempt Citation or a finding of Contempt of Court

Please note that the following criteria apply in order to determine whether your Warrant(s) are eligible for participation in the Surrender to Freedom program:

- 1) The Warrant MUST be issued by a Delaware County Court (Including Muncie City Court);
(NOTE: we CANNOT vacate warrants issued by courts in other counties and/or states)
- 2) The Warrant must fall under one of the following categories:
 - a. Warrants issued for Failure to Appear (FTA) at a previously scheduled court hearing.
 - b. Arrest Warrants issued for non-violent offenses classified as Level 3 Felony or below; OR Class C Felony or below.
 - c. Warrants out of Drug Court or Veteran's Court for Failure to Appear at Review Hearing.
 - d. Warrants issued pursuant to a Probation Revocation where the ONLY violations are:
 - i. Failure to Report, and/or
 - ii. Failure to Pay Fees

Warrants that are **NOT** eligible:

- 1) Arrest Warrants issued for violent crimes, which include, but are not limited to:
 - a. Battery (all types and classifications)
 - d. Rape
 - e. Child Molestation
 - f. Murder
 - g. Arson
 - h. Robbery
 - j. Leaving the Scene of an Accident resulting in Death or Serious Bodily Injury
 - k. Operating While Intoxicated Resulting in Death or Serious Bodily Injury
- 2) Child Support Warrants issued by Title IV-D Court
- 3) Civil Warrants (Body Attachments)
- 4) Tax Warrants
- 5) Warrants issued pursuant to a Contempt Citation / finding of Contempt of Court
- 6) Juvenile Court Warrants

Order Concerning Surrender to Freedom Program

WHEREFORE, the Judges of the Delaware Circuit Court have been advised of the Surrender to Freedom Program, which is set to take place on or about Monday January 14, 2019, at the Muncie Mission. The Judges have been further advised that this program will consist of community stakeholders attempting to aid members of the community who are suffering from or dealing with an addiction with locating appropriate treatment options.

WHEREFORE, the Judges of the Delaware Circuit Court have agreed that that any individuals who appear at the Surrender to Freedom Program and who have a “qualifying warrant” will not be arrested on said warrant. Rather, said individuals shall be provided with a notice of hearing that will state a date and time for those individuals to produce themselves in the court from which said “qualifying warrant” was issued. “Qualifying warrants” are defined as follows:

- 1) The Warrant **MUST** be issued by a Delaware County Court (Including Muncie City Court);
- 2) The Warrant **MUST** fall under one of the following categories:
 - a. Warrants issued for Failure to Appear (FTA) at a previously scheduled court hearing;
 - b. Arrest Warrants issued for non-violent offenses classified as Level 3 Felony or below; OR Class C Felony or below;
 - c. Warrants issued out of Drug Court or Veteran’s Court for Failure to Appear at a previously scheduled Review Hearing; or
 - d. Warrants issued pursuant to a Probation Revocation where the **ONLY** violations are:

 - ii. Failure to Pay Fees

The Judges have been further advised that the following warrants would not qualify for participation in the Surrender to Freedom Program:

- 1) Arrest Warrants issued for any violent crime, which include, but are not limited to:

 - f. Murder;
 - g. Arson;

- h. Robbery;
- j. Leaving the Scene of an Accident resulting in Death or Serious Bodily Injury;

- 2) Civil Warrants (Body Attachments);
- 3) Tax Warrants; and
- 4) Warrants issued pursuant to a Contempt Citation or a finding of Contempt of Court

WHEREFORE, the Judges of the Delaware Circuit Court believe that participation in the Surrender to Freedom Program would be beneficial for any individual that may be suffering from or dealing with an addiction.




