**ORDINANCE NO 2014-039A**

**ORDINANCE AMENDING  
ORDINANCE NO. 2013-006 AN ORDINANCE ESTABLISHING THE EXCISE  
SURTAX AND THE WHEEL TAX ON MOTOR VEHICLES IN THE COUNTY AND  
ESTABLISHING THE DELAWARE COUNTY SURTAX FUND AND THE DELAWARE  
COUNTY WHEEL TAX FUND AND REPEALING ORDINANCE NO. 2009-24A**

**Whereas**, the Delaware County Council previously enacted Ordinance No. 2013-\_\_\_\_, and established the Excise Surtax and the Wheel Tax on Motor Vehicles in the County and Established the Delaware County Surtax Fund and the Delaware County Wheel Tax Fund, pursuant to Indiana Code 6-3.5-4 and Indiana Code 6-3.5-5.

**Whereas**, the Legislature has amended Indiana Code 6-3.5-4-2 to include Motor Driven Cycles as a vehicle class to be covered by the surtax.

**Whereas**, it is the intent of the Delaware County Council to amend its previously enacted Ordinance to include Motor Driven Cycles as a vehicle class to be assessed the surtax.

**NOW, THEREFORE, BE IT ORDAINED BY THE COUNTY COUNCIL OF DELAWARE COUNTY, INDIANA THAT:**

1. Beginning January 1, 2015, all motor driven cycles registered in Delaware County that are now subject to an excise tax shall also be subject to an annual excise surtax of Twenty Five Dollars (\$25.00) to be paid with the registration of said motor vehicle.
2. All other provisions of Delaware County Ordinance NO. 2013-\_\_\_\_ not in contradiction with this ordinance shall remain in full force and effect.
3. This ordinance shall be in full force and effect January 1, 2015 and its publication as provided by law.


