

## AGREEMENT


This Agreement, entered into on this 20<sup>th</sup> day of March, 2013, between the City of Muncie, Indiana (**City**) and Delaware County, Indiana (**County**) is for the purpose of delegating duties of maintenance and operation of certain segments of roads and certain electronic traffic signals and the implementation of snow and ice control on bridges within the City limits and identified further in this Agreement.


- I. With this Agreement, the **City and County** agree to divide the duties of maintenance and operations of the following described portions of roads in the following manner:
  - A. Maintenance and operations as referred to in this Agreement shall include the following activities:
    1. Snow and ice control except as described elsewhere in this Agreement;
    2. Pavement marking and traffic signage;
    3. Minor maintenance (mowing, patching, tree trimming, etc.); and
    4. Issuance of permits and monitoring of the work completed under such permits for activities within the right-of-way (street-cuts, drive-way/mailbox permits, temporary closure, etc.
- II. The **City and County** shall share the aforementioned duties as follows:
  - A. The **County** shall be responsible for the following segments of roads:
    1. Bethel Avenue from Morrison Road to Benton Road/CR 350 W
    2. Walnut Street from Riggin Road to the north City limit
    3. Wheeling Avenue from Airway Drive (Dice Acres) to the north City limit
    4. Butterfield Road from SR 32 to Memorial Drive
    5. Burlington Drive from Muncie By-pass to the south City limit
    6. Walnut Street from South Madison Street to CR 300 S
    7. Fuson Road (CR 300 S) between Walnut Street to Madison Street
    8. Hoyt Avenue from Cornbread Road to the south City limit
    9. 26<sup>th</sup> Street between Tillotson Avenue and Hoyt Avenue
    10. Proctor Road from Kilgore Avenue/State Road 32 to south Cornbread Road(CR 150 S)
    11. County Club Road from State Road 32 to the south City limit
    12. Eaton Avenue from Muncie By-pass to the south City limit
    13. County Club Road from CR 25 N to the north City limit
  - B. The **City** shall be responsible for the following segments of roads:
    1. Wheeling Avenue from Airway Drive (Dice Acres) to Riggin Road
    2. Riggin Road between Everett Road and Muncie By-pass
    3. County Club Road between SR 32 and CR 25 N
    4. McGalliard Road from Muncie By-pass to the west
    5. Shirey Road between McGalliard Road and Centennial Avenue
    6. Centennial Avenue from Muncie By-pass to the west
    7. 23<sup>rd</sup> Street between Cowan Road and the Norfolk & Southern railroad tracks
    8. Tillotson Avenue between Cornbread Road and 26<sup>th</sup> Street
    9. Cornbread Road between Perdieu Road and Tillotson Avenue
    10. Perdieu Road between Cornbread Road and Kilgore Avenue
    11. Morrison Road between Bethel Avenue and CR 350 N
    12. CR 25 N west of Country Club Road
    13. Benton Road from Bethel Avenue to SR 332
    14. Hessler Road between Benton Road and Morrison Road



- III. The City shall, when treating roads for snow and ice control and applying pavement markings, treat bridges within its boundaries the same as it would the streets approaching the bridge.
- IV. The City shall be responsible for minor maintenance of all traffic signals and bridge lighting within the County's jurisdiction. In exchange, the County will provide materials to repair signals and lighting within the County's jurisdiction.
- V. The City shall be responsible for snow and ice removal on bridges including sidewalks within City limits. In exchange, the County will provide, as needed, 75-tons of product for snow and ice removal. The purchasing of such product shall include the option of a City/County co-op purchase.
- VI. Either party may terminate this Agreement upon thirty (30) days written notice.




