

NOW THEREFORE BE IT RESOLVED, by the Board of Commissioners of Delaware County, Indiana, as follows:



The Commissioners shall have no obligation to satisfy the terms, or any parts thereof, of the Interlocal Agreement until the Town Council for the Town of Eaton, Indiana adopts a substantially similar resolution and the Interlocal Agreement is fully executed by the parties and properly recorded as required by law.

DULY ADOPTED by the Board of Commissioners of Delaware County at a regularly scheduled public meeting held on this, the 16 day of March, 2020.


