Disaster Emergency Declaration 2020-18

Delaware County, Indiana

- WHEREAS, the President of the United States, on March 13, 2020, has declared a nationwide emergency concerning the spread of COVID-19 viral infections, and
- WHEREAS, the Governor of the State of Indiana, on March 16, 2020, has made an emergency declaration in response to the Coronavirus (COVID-19) disease epidemic; and
- WHEREAS, the County Health Officer has determined that certain measures should be put into place to lessen the potential spread of the COVID-19 virus including the closing of some local businesses; and
- WHEREAS, pursuant to I. C. 10-14-3-29(a) the Board of Commissioners of Delaware County, IN hereby makes a local disaster emergency declaration; and
- WHEREAS, the trend in Delaware County for the past month has shown a significant increase in COVID-19 cases and the positivity rate for the last 7 days is 9.4% for the County; and
- WHEREAS, there have been a total of 3,263 cases in Delaware County to date with an increase of 1,043 cases in October alone and IU Ball Memorial Hospital is at or near capacity; and
- WHEREAS, younger members of the populace have been testing positive in greater numbers as well as greater illness rates among younger and younger people;
- WHEREAS, the Board of Commissioners of Delaware County, Indiana have determined that in response to the emergency believes that an Emergency Declaration is appropriate for the citizens of Delaware County and that the Emergency Declaration should be extended.

NOW THEREFORE WE, THE BOARD OF COMMISSIONERS OF DELAWARE COUNTY, INDIANA HEREBY DECLARE THAT:


1. A local public health disaster continues to exist in the County and that we hereby invoke and declare those portions of the Indiana Code which are applicable to the conditions and have caused the issuance of this proclamation, to be in full force and effect in the entire County, including incorporated areas for the exercise of all necessary emergency authority for protection of the lives and property of the people of this County and the restoration of local

government with a minimum of interruption. This Emergency Order is effective immediately and shall be in place until the end of business November 16, 2020.

- 2. All employees in any county facility shall wear a face covering their nose and mouth at all times except while working in their own workspace, provided that the workspace is spaced more than 6' from other work spaces. Additionally, employees shall not be required to wear facial coverings when working outside (if they are working in an environment that allows for social distancing), in a vehicle by themselves or working remotely. Employees of the County shall also wear facial coverings when moving about the hallways, common areas, restrooms or other areas of the County facilities when not at their work space.
- 3. All members of the public that conduct business in any county building or facility shall maintain a social distance of at least 6 feet between individuals at all times and shall wear a face covering over the nose and mouth when inside any public building or other indoor space open to the public. This does NOT apply to private offices, private workplaces or meetings where social distancing can be achieved and maintained between people not in the same household. Member of the public are required to wear a face mask or other covering which covers the person's mouth and nose during their business in the County Building unless the member of public prohibits a face covering because of an underlying health condition prohibits wearing a face covering.
- 4. In instances where an individual must visit a retail business, the business shall follow the proper social distancing requirements in Executive Order 20-43 and the guidelines from the Center for Disease Control (CDC).
- 5. Those residents that meet the below stated criteria are not required to wear a facial covering:







The courts are required to submit a COOP (Continuity of Operations Plan) to the State by January 2021. It is a written plan if an emergency/pandemic occurs and we cannot operate at our facility. The judges and I have been working on it and are at the end of finalizing the draft. I provided the section below out of the COOP that deals with what I need to present at the meeting. The highlighted area is specific to what I need to get approved from the Commissioners. I will explain more at the meeting but if you have any questions before then please let me know. Thanks. Emily

Phase III: Procedures for Alternative Facility Operations

The Delaware Circuit Courts operate in three locations (as of November, 2020, they will operate in two locations, so the Plan will not address the third location.) The two locations the Plan will address are: the Delaware County Justice Center/Jail Complex; and the Juvenile Court Division located at the Youth Opportunity Center Complex on West Kilgore Avenue, Muncie, Indiana.

The Juvenile Court Division: if the Juvenile Court Division is not able to conduct essential functions at the Youth Opportunity Center Complex, the Juvenile Court Division will relocate to the Delaware County Justice Center. The Coordinator will find space for staff to relocate. The Coordinator will find courtrooms in which the Juvenile Magistrate can conduct hearings until operations can resume at the YOC Complex.

Equipment and computer needs will be addressed depending on what equipment and computers the Magistrate and Staff are able to bring from the YOC Complex safely. No one is expected to put themselves at risk to "salvage" or "save" computers or equipment.

The Delaware County Justice Center: if the Delaware County Justice Center is not available for the courts to use for essential functions, the Board of Judges has selected the following alternate site:

The Commissioners' Courtroom in the Delaware County Building

The Board of Judges will arrange through the Delaware County Commissioners to enter a Memorandum of Understanding in order to have this space available if the Board of Judges must activate this portion of the Plan.

WHEREAS, the services will be of benefit to the populace of Delaware County and the State of Indiana in the following manner: Extension Service Programs to include: 4-H YOUTH DEVELOPMENT, LEADERSHIP and COMMUNITY DEVELOPMENT. AGRICULTURE and NATURAL RESOURCES, and HEALTH AND HUMAN SCIENCES; and.

This agreement applies only to those positions specifically stated herein.
- It is understood that the results of the services or reports of activities may be published by the University in such form as may be approved by the University.
- Any funds not expended or committed for said services can be made available for other uses benefiting
 the contributing county's Extension programs. Possible uses could include other salary support, supplies,
 capital equipment.
- It is further understood that this agreement may be renewed at the expiration date subject to the approval
 of the County and the University.
- This Agreement supercedes any and all prior Agreements made between the parties for the subject matter herein.

Memorandum of Understanding: Purdue Extension Contractual Services Agreement in Delaware County

The contractual services agreement between Purdue University and the government of **Delaware** County provides financial support for county extension services in four program areas; agriculture and natural resources, health and human sciences, community development and 4-H youth development. These services include access to services from county educators, campus specialists at Purdue University,

Counties may enhance local service delivery with additional funding, which would include hiring additional Purdue staff for the county Extension office.

RESOLUTION OF THE DELAWARE COUNTY, INDIANA, BOARD OF COMMISSIONERS AMENDING AND RESTATING RESOLUTION 2020-037, APPROVING JOINT UNDERTAKING AGREEMENT, PLEDGING INCREMENT TO THE DALEVILLE REDEVELOPMENT COMMISSION, AND AUTHORIZING EXECUTION OF DOCUMENTS

WHEREAS, pursuant to Resolution No. 2019-05, the Town Council of the Town of Daleville, Indiana (the "Town Council"), adopted the provisions of Ind. Code §5-23, et seq. (the "BOT Statute"), and authorized the issuance of a request for proposals to develop, design, and construct a town hall and police station (the "BOT Project");

WHEREAS, pursuant to Daleville Town Council Resolution 2019-11, and in accordance with the requirements of the BOT Statute, the Town Council awarded the development, design, and construction of the BOT Project to Daleville Police Station Partners, LLC (the "Developer"), and authorized the negotiation and execution of a build-operate-transfer agreement (the "BOT Agreement"), compliance with which will be subject to: (a) approval by the Delaware County Board of Commissioners (the "County Board") and the Delaware County Redevelopment Commission (the "County RDC") of a pledge of financial support adequate to pay all installment payments payable by the Town of Daleville, Indiana (the "Town") pursuant to the BOT Agreement (the "BOT Payments"); and (b) the actual pledge of such adequate financial support to the Daleville Redevelopment Commission (the "Daleville RDC");

WHEREAS, the Town Council submitted to the County Board and the County RDC a proposal for the joint undertaking of the BOT Project pursuant to Ind. Code §36-7-25-4 (the "Joint Undertaking Statute");

WHEREAS, each of the County Board (pursuant to Resolution 2020-003) and the County RDC (pursuant to Resolution 2020-002) determined it to be in the best interests of Delaware County, Indiana, to work jointly with the Town on economic and quality of life projects;

WHEREAS, pursuant to Resolution 2020-003, the County Board designated the County RDC as the appropriate entity to enter into discussions with the Daleville RDC for the purposes of agreeing to the terms and conditions on which the BOT Project will be undertaken jointly, which terms and conditions would be subject to the approval of the Town Council and the County Board;

WHEREAS, pursuant to Resolution 2020-002, the County RDC agreed to engage in such discussions, subject to the requirement that it would execute a joint agreement with the Daleville RDC only upon the specific determination that the BOT Project will serve or benefit the allocation areas within the "Daleville Redevelopment Area" (the "Allocation Area");

WHEREAS, having made the required determinations, the County RDC and the Daleville RDC proceeded to agree on the terms and conditions of an agreement pursuant to which the BOT Project will be undertaken jointly, as permitted pursuant to the Joint Undertaking Statute (the "Joint Undertaking Agreement");

WHEREAS, the Joint Undertaking Agreement requires: (a) the Town to enter into the BOT Agreement; (b) the County Board to pledge to the Daleville RDC the increment generated in the Allocation Area (the "County Increment"); provided that: (i) the aggregate amount of that portion of the BOT Payments comprised of principal shall not exceed \$4,300,000.00; (ii) the annual amount pledged to the Daleville RDC for a given year shall be capped at the amount required to pay the BOT Payments for such year; and (iii) the aggregate amount pledged to the Daleville RDC shall not exceed the amount required to pay all of the BOT Payments (collectively, the "County Increment Cap"); (c) the County RDC to confirm the pledge of the County Increment (subject to the County Increment Cap) by the County Board, and, to the extent permitted pursuant to pursuant to Ind. Code §36-7-14-39, to further pledge the County Increment (subject to the County Increment Cap) to the Daleville RDC; and (d) the Daleville RDC to: (i) accept the County Increment, subject to the County Increment Cap (such amount, the "Pledged Revenue"); and (ii) pledge the Pledged Revenue received by it to the payment of the BOT Payments for the term of the BOT Agreement;

WHEREAS, pursuant to the Joint Undertaking Statute, the County Board has the authority to pledge the County Increment to the Daleville RDC, notwithstanding that the BOT Project will not be constructed in the Allocation Area;

WHEREAS, to provide funds for the payment of costs and expenses that will be incurred in connection with the development, design, and construction of the BOT Project, including those incurred in connection with finalizing the required documentation, the Town, the Developer, a lender selected by the Developer and acceptable to the Town, and, as applicable, the Daleville RDC, the County Board, and/or the County RDC, will enter into a participation and purchase agreement (the "Participation Agreement") pursuant to which the Developer will absolutely assign to such lender its right to receive the BOT Payments;

WHEREAS, at a regularly scheduled meeting held on October 5, 2020, the County Board adopted Resolution 2020-037, pursuant to which the County Board: (a) approved, and authorized the execution of, the Joint Undertaking Agreement, the Participation Agreement, and any other documents or instruments necessary to close on the transaction contemplated in the BOT Agreements (the "Transaction Documents"); and (b) pledged the Pledged Revenue to the Daleville RDC in accordance with the Joint Undertaking Statute for further pledge by the Daleville RDC to the payment of the BOT Payments;

WHEREAS, contemporaneously with the adoption by the County Board of Resolution 2020-037, the Town Council, the Daleville RDC, and the County RDC adopted resolutions approving, and authorizing the execution of, the Joint Undertaking Agreement, which resolutions, contemporaneously with the adoption by the County Board of this Resolution, are being amended, restated, and superseded to be consistent herewith;

WHEREAS, contemporaneously with the adoption by the County Board of Resolution 2020-037, the Town Council adopted a resolution: (a) confirming the award of the BOT Project to the Developer; and (b) approving, and authorizing the execution of, the BOT Agreement and the Participation Agreement; which resolution, contemporaneously with the adoption by the County Board of this Resolution, is being amended, restated, and superseded to be consistent herewith;

documents or certificates executed and delivered, hereby are ratified, confirmed, and approved.

- 5. No Conflict. This Resolution amends, restates, and supersedes in its entirety Resolution 2020-037. All ordinances, resolutions, and orders (or parts thereof) that conflict with the provisions of this Resolution hereby are repealed to the extent of such conflict. After the issuance of the BOT Agreement, and until all BOT Payments have been paid (or prepaid) in full, and except as expressly provided herein: (a) this Resolution shall not be repealed or amended; and (b) the County Board shall not adopt any ordinance or resolution that in any way adversely affects this Resolution.
- 6. Severability. If any section, paragraph, or provision of this Resolution is held to be invalid or unenforceable for any reason, then the invalidity or unenforceability of such section, paragraph, or provision shall not affect any of the remaining provisions of this Resolution.
- 7. Effectiveness. This Resolution shall be in full force and effect from and after its passage.

A RESOLUTION OF THE DELAWARE COUNTY, INDIANA BOARD OF COMMISSIONERS IDENTIFYING TAX SALE CERTIFICATES TO BE ASSIGNED TO NONPROFIT ENTITIES PURSUANT TO IND. CODE § 6-1.1-24-6.7

WHEREAS, Ind. Code §§ 6-1.1-24-6.7 and 6-1.1-24-17 set out the procedures the Board of Commissioners may utilize to assign tax sale certificates to a nonprofit entity;

WHEREAS, the Board of Commissioners has identified the parcels of real property identified on Exhibit A, attached hereto, for which the Board of Commissioners currently hold tax sale certificates, has been in one or more tax sales, and has taxes which remain severely delinquent;

WHEREAS, the Board of Commissioners now desires to assign the tax sale certificate for the above-referenced properties to nonprofit entities for use for the public good;

WHEREAS, the Board of Commissioners intends to accept written applications from eligible nonprofit entities that satisfy the requirements of Ind. Code § 6-1.1-24-6.7 and desire to have the tax sale certificate for the identified properties assigned to them; and

WHEREAS, the Board of Commissioners will conduct a public hearing to consider all submitted applications and hear any opposition to the proposed assignments.

IT IS THEREFORE RESOLVED BY THE BOARD OF COMMISSIONERS OF DELAWARE COUNTY, INDIANA THAT:

<u>SECTION 1</u>. The Board of Commissioners hereby identifies the properties identified on <u>Exhibit A</u>, attached hereto, as those for which the Board of Commissioners hold tax sale certificates and now desires to assign said certificates to nonprofit entities for use for the public good.

SECTION 2. The Board of Commissioners will conduct a public hearing to consider the assignment of the tax sale certificates to eligible nonprofit entities and said public hearing shall occur on the 16th day of November, 2020, at 9:00 a.m. in the Delaware County Commissioner's Courtroom, Room 309, 100 West Main Street, Muncie, Indiana 47305.

SECTION 3.
