RESOLUTIION 2021-017

A RESOLUTION OF THE BOARD OF COMMISSIONERS ESTABLISHING THE POLICY BY WHICH MEMBERS OF THE BOARD OF COMMISSIONERS MAY PARTICIPATE BY ELECTRONIC MEANS OF COMMUNICATION

WHEREAS, P.L. 88-2021 (HEA 1437), SEC. 5, amended IC 5-14-1.5-1 et seq. (Act), effective April 20, 2021 by amending IC 5-14-1.5-3.5 to prescribe new requirements by which members of the governing body of a public agency of a political subdivision may participate in a meeting by any electronic means of communication;

WHEREAS, a member of the governing body may participate by any means of communication that:

- Allows all participating members of the governing body to simultaneously communicate with each other; and
- Except for a meeting that is an executive session, allows the public to simultaneously attend and observe the meeting;

WHEREAS, the Act requires the governing body to adopt a written policy establishing the procedures that apply to a member's participation in a meeting by an electronic means of communication and may adopt procedures that are more restrictive than the procedures established by IC 5-14-1.5-3.5(d); and

WHEREAS, the Delaware County Board of Commissioners (Board) is a governing body of Delaware County, Indiana:

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF DELAWARE COUNTY, INDIANA:

Section 1. (a) The provisions of the Act, including definitions, apply to this resolution.

(b) This resolution shall be known as the "Electronic Meetings Policy" of the Board and applies to the Board and any committee appointed directly by this Board or its presiding officer.

Section 2. (a) Subject to Sections 3 and 5 below, any member may participate in a meeting by any electronic means of communication that: (i) allows all participating members of the governing body to simultaneously communicate with each other; and (ii) other than a meeting that is an executive session, allows the public to simultaneously attend and observe the meeting.

(b) A member who participates by an electronic means of communication:

(i) shall be considered present for purposes of establishing a quorum; and (ii) may participate in final action only if the member can be seen and heard.

(c) All votes taken during a meeting at which at least one member participates by an electronic means of communication must be taken by roll call vote.

Section 3. A technological failure in an electronic means of communication that disrupts or prevents:

- (a) The simultaneous communication between a member who is not physically presents the meeting and the governing body; or
- (b) A member of the public who is not present at the meeting from attending and observing the meeting;

does not prevent the Board of Commissioners from conducting the meeting or effect the validity of an action taken by the Board of Commissioners if the sum of the members physically present at the meeting and the members participating by electronic communication without technological failure satisfy the quorum of the board of commissioners and the voting requirements of the Board.

Section 4. At least fifty percent (50%) of the members must be physically present at a meeting at which a member will participate by means of electronic communication. Not more than fifty percent (50%) of the members may participate by an electronic means of communication at that same meeting.

Section 5. A member may not attend more than a fifty percent (50%) of the meetings in a calendar year by an electronic means of communication, unless the member's electronic participation is due to:

(i) military service;

(ii) illness or other medical condition;

(iii) death of a relative; or

(iv) an emergency involving actual or threatened injury to persons or property.

Section 6. A member may attend two (2) consecutive meetings (a set of meetings) by electronic communication. A member must attend in person at least one (1) meeting between sets of meetings that the member attends by electronic communication, unless the member's absence is due to:

- (i) military service;
- (ii) illness or other medical condition;
- (iii) death of a relative; or
- (iv) an emergency involving actual or threatened injury to persons or property.

Section 7. The minutes of a meeting at which any member participates by electronic means of communication must:

(1) identify each member who:

(i) was physically present at the meeting;

(ii) participated in the meeting by electronic means of communication; and (iii) was absent; and

(2) identify the electronic means of communication by which:

(i) members participated in the meeting; and

(ii) members of the public attended and observed the meeting if the meeting was not an executive session.

Section 5. No member of the Board may participate by means of electronic communication in a meeting at which the Board may take final action to:

(a) adopt a budget;

(b) make a reduction in personnel;

(c) initiate a referendum;

(d) impose or increase a fee;

(e) impose or increase a penalty;

(f) exercise the Board's power of eminent domain; or

(g) establish, impose, raise or renew a tax.

Section 6. This resolution shall be effective from and after adoption by this Board and compliance with IC 36-2-4-8.

Mr. Brooke presented Resolution 2021-018, A Resolution to opt out of Opioids Settlement. The State of Indiana adopted in the budget bill restrictions on the ability for Delaware County to participate in the opioids lawsuit. Legislature allowed counties and municipalities to opt out due to it being unfair to the communities. The State would be taking 85 to 90% of the funds restricting the counties to pursue possible remedies.

WHEREAS. Delaware County has sustained damages from the loss of its citizens, to the addiction crimes and destruction of families as a result of the opioid crisis in the United States; and

WHEREAS, Delaware County has been forced to expend its resources and efforts to combat the impact of the devastation and loss resulting from the addiction to opioids that have been foist upon the community by many, many different purveyors of a highly narcotic and addictive medication; and

WHEREAS, the Board of Commissioners has been involved in the multi-district opioid litigation as a county entity seeking compensation from those companies and individuals responsible for creating and maintaining the opioid crisis in the community; and

WHEREAS, the Board of Commissioners have determined that it is in their best interest and the best interest of the citizens of Delaware County, Indiana that it opt out of any opioid settlements involving municipal and state governments.

NOW THEREFORE BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF DELAWARE COUNTY, INDIANA that:

1. The County of Delaware, having considered whether to elect to opt out of the Opioids Settlements under Indiana Code 4-16-15-2, hereby resolves that Delaware County, Indiana now exercises its election to opt out of opioids settlement, and orders its duly authorized agent to submit a certified copy of this resolution to the Indiana Attorney General by June 30, 2021.

2. The Auditor of Delaware County, Indiana shall transmit a certified copy of this Resolution o the Attorney General for the State of Indiana on or before June 30, 2021.

RESOLUTION OF THE DELAWARE COUNTY, INDIANA BOARD OF COMMISSIONERS TO TRANSFER COUNTY-OWNED REAL PROPERTY TO THE MUNCIE SANITARY DISTRICT

WHEREAS, the Delaware County Board of Commissioners, as the legislative body and executive of Delaware County, Indiana (hereinafter, the "Commissioners"), owns certain real property located in the City of Muncie, Indiana, which is specifically identified on **EXHIBIT A**, attached hereto (hereinafter, the "County Property");

WHEREAS, the Board of Sanitary Commissioners, as the governing body of the Muncie Sanitary District (the "District"), owns certain real property located in the City of Muncie, Indiana, which is immediately adjacent to the County Property and used by the District in providing sanitation services to its users;

WHEREAS, the District desires to acquire the County Property from the Commissioners to be used to improve efficiency in the provision of wastewater and other sanitation-related services to its users; and

WHEREAS, the Commissioners desire to transfer said County Property to the District, subject to acceptance of said County Property by the District and upon the terms and conditions stated herein.

NOW THEREFORE BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF DELAWARE COUNTY, INDIANA THAT:

- The Delaware County Board of Commissioners shall transfer said County Property, as described in <u>EXHIBIT A</u>, attached hereto, to the Muncie Sanitary District upon acceptance of the County Property by the District and upon the condition that the County Property shall only be used for the purpose of improving efficiency in the provision of wastewater and other sanitation-related services to its users by whatever means reasonably necessary, as determined by the District's Board of Sanitary Commissioners.
- The District's acceptance of the County Property shall be demonstrated by the adoption of a substantially similar resolution by the District's Board of Sanitary Commissioners, a copy of which shall be provided to the Commissioners upon its adoption by the District's Board of Sanitary Commissioners.
- 3. The Delaware County Auditor shall provide an executed copy of this Resolution to the District's Board of Sanitary Commissioners and, upon receipt of a substantially similar resolution adopted by the District's Board of Sanitary Commissioners, the President of the Board of Commissioners of Delaware County, Indiana shall be authorized to execute all necessary documents to facilitate and carry out said transfer of the County Property to the District.
