Mr. John Brooke, County Attorney, said after much discussion with Delaware County Highway Department, Delaware County is rejecting the INDOT offer. An unofficial detour on Highway 28 took place with repairs costs being estimated around \$300,000, however INDOT offered \$50,000. Mr. Brooke will send a reject letter due to the cost difference of INDOT's offer compared to Delaware County estimates.

AN ORDINANCE TO LIMIT WEIGHT AND COMMERCIAL TRUCK TRAFFIC

Mr. Brooke said due to trucks being diverted onto county roads from State Highways, the Commissioners requested the presented Ordinance. Ordinance 2021-026, An Ordinance to Limit Weight and Commercial Truck Traffic on County Roads is in regards to INDOT detours. The roads cannot handle the semi-trailers on an ongoing basis.

A RESOLUTION RESCINDING DELAWARE COUNTY PUBLIC SAFETY  
EMPLOYEE HANDBOOK HIGHWAY-BRIDGE-ENGINEERING EMPLOYEE MANUAL  
RESOLUTION 2021-031

Mr. Brooke presented Resolution 2021-031, rescinding the Handbook for Highway-Bridge-Engineering. The Highway had their own handbook when they were Union. In working with Ms. McCammon, it has become difficult because some of their rules were different from the counties handbook. Mr. Brooke said due to consistency, the Delaware County handbook should be used for Highway-Bridge and Engineering.

DEPARTMENT HEADS AND ELECTED OFFICIALS

Mr. Paul Singleton, 911 Director, said several months ago the Commissioners had authorized a software upgrade with Tyler Technologies. This upgrade effects Muncie City Police, Jail, Sheriff and mobile units of small towns. Jail, 911, City Police and Sheriff Department are short on staff, Mr. Singleton recommended that the upgrade does not go into effect until second quarter of 2022. The build out process should be finished, Mr. Jim Flook, IT Director is in agreement. This is a complete different platform. This will give more time for testing to ensure that this upgrade is done correctly.

All Commissioner are in agreement.

October dates will be cancelled and rescheduled for second quarter of 2022. Mr. Singleton will call after today's meeting to let Tyler Technologies know of the changes regarding the upgrade.

Mr. Tommy Humbert, Highway Superintendent and Mr. Bobby Daugherty, Highway Department shared concerns with issues and safety measures on 300 south and SR 35 and Meeker Avenue closing. Warning signs will be placed in the areas. Signage has to be added to be more visual to upcoming traffic. Drainage and right-of-way may have to be considered due to big trucks traveling the roads.

Ms. Laurynn Thieme, Extension Director, provided an update of the 2021 Delaware County Fair.

Commissioner Henry thanked Ms. Meagan Coutinho, EMS Administrator. Ms. Coutinho is an EMT and has worked a couple of shifts for EMS. Commissioner Henry stated that this is the type of people we have working in EMS. Much appreciation to Ms. Coutinho.

President King supports all Public Safety Officers-Law Enforcement for raises. King is in agreement that they are underpaid and the respect is no longer there for officers. Commissioners do not give raises, however, this is done through County Council. American Rescue Plan monies cannot be used for raises. ARP monies can only be used for specific things. The Commissioners are working on bringing revenue back into the county to build tax base up. Money generated from out of county inmates is used for meals within the Jail.

Mr. Brooke confirmed President King is correct and that ARP monies cannot be used for raises, personnel, retirement. ARP monies can be used for COVID, infrastructure, water sewer broadband and stormwater.

Mr. Brad Bookout, Economic Development said assessed value is up \$79 million in the last 4 years. Rural areas assessed values have gone up in the county too.

Mr. Jeff Stanley, Chief Deputy, said monies received for out of county inmates goes directly to county general. Mr. Stanley, Sheriff Skinner and Councilmembers have met and are trying to come up with solutions.

Commissioner Riggin is in hopes that all can come together to keep the Public Servants safe and paid what they deserve.




