

ORDINANCE 2021-33-A

**AMENDED ORDINANCE AMENDING TITLE 1, CHAPTER 4, SECTION 2 OF
THE DELAWARE COUNTY CODE OF ORDINANCES REGARDING ELECTION
DISTRICTS FOR COUNTY COUNCIL**

WHEREAS, every ten years a census occurs in the United States as required by the Constitution and the decennial census for the United States was completed in 2020 and the results were shared with the general public on August 12, 2021; and

WHEREAS, as a part of the process of the census, local governments that conduct elections by districts must review the census information and determine if there have been any changes in population for the County as a whole and if there were any significant changes in the population totals for each of the four County Council districts; and

WHEREAS, before County Council districts can be completed, the Legislature must draw the district lines for Senate and House of Representative positions and then the Commissioners must review the current precincts to determine their viability; and

WHEREAS, the Indiana Legislature completed their work on legislative district lines on September 30, 2021 and the Delaware County Board of Commissioners completed their review of the precincts in the County with the Clerk on October 31, 2021; and

WHEREAS, the Board of Commissioners have reviewed the census data and determined that the County Council election districts shall be determined in this ordinance.

IT IS THEREFORE ORDAINED BY THE BOARD OF COMMISSIONERS OF DELAWARE COUNTY, INDIANA that:

1. The county is divided into four (4) county council election districts designated numerically as follows:

District 1: Precinct numbers-94, 81, 23, 13, 81, 87, 53, 20, 95, 22, 41, 19, 15, 1, 54, 52, 51, 71, 44, 14, 9, 87.

District 2: Precinct numbers-50, 34, 25, 8, 78, 56, 38, 6, 26, 3, 36, 10, 4, 98, 88, 57, 74, 55, 33, 58.

District 3: Precinct numbers-40, 39, 35, 18, 43, 48, 11, 20, 28, 41, 7, 73, 59, 62, 75, 12, 46, 29.

District 4: Precinct numbers-49, 66, 64, 77, 61,63, 69, 65, 47, 60, 27, 8, 45, 2, 92, 70, 93, 90, 67, 68, 42, 91, 5.


2. Any and all existing ordinances, orders, and/or resolutions, or any parts thereof, which may be in conflict with this Ordinance, are hereby superseded.

3. This Ordinance shall take effect upon adoption as required by law.
