### JUDGE WOLF-MAGISTRATE POSITION

Judge Wolf presented information regarding changing the position of Master Commissioner to Magistrate. At the end of the hearings, the Master Commissioner's findings and recommendations are sent to the Judge for review. This causes a delay in getting the decision to the litigants. Litigants are waiting on the sitting Judge to review the recommendations, sometimes the Judge is in court so the review may not happen until the end of day or next day. There are several steps to the process. If the position was changed, the Magistrate could/would have the authority to make a decision and also handle criminal cases.

Benefits and retirement would be paid through the State because the Magistrate is a State employee. The total amount of county general would be \$35,314.20 compared to the current cost of \$77,730.65. General Assembly determine State salaries.

A County Council letter of support addressed to the Summer Study Committee is needed before the next step could be taken.

Ms. Emily Anderson, Court Administrator, asked that the savings be moved to other line items due to some expected increases, jury trials are back logged and jury fees have to be paid. If the Magistrate position was approved this would give the Magistrate authority to make decisions without the Judges review and save time.

### **DEPARTMENT HEADS**

Ms. Pam McCammon, Human Resource Director, said she wanted to mention to Council since Ms. Donna Patterson, Auditor Deputy, mentioned that rates for long and short term disability doubled (per Ms. Julie Castor, Insurance Clerk) that she contacted the insurance representative and was told that the rates did not go up. Ms. McCammon said the only way the rates would have gone up is if an individual within a department got more insurance. Short term and long term are paid by the county. There were several that signed up for an extra \$10,000 life insurance and this could be where they are getting higher rates. Again, Ms. McCammon stated she was not notified of rates going up.

Ms. Patterson said the county portion doubled, per Ms. Castor. The billings doubled, a lot of employees would have had to be added to double. Someone will need to review this because the county is paying out double on short term disablilty.

Ms. Tony Skinner, Sheriff, said the department is ten employees short, four employees went to other local agencies. Overtime has been offered to Merit officers to help in the Jail, 50% of overtime budget has been used since January 2022.
