**AN ORDINANCE AMENDING TITLE 4, CHAPTER 2
OF THE DELAWARE COUNTY CODE REGARDING PERMIT FEES**

WHEREAS, the Board of Commissioners, in accordance with state statutes, may adopt building and permitting ordinances that include reasonable fees for permits, registrations, renewals, inspections and re-inspections; and

WHEREAS, minor increases and revisions have been deemed necessary; and

WHEREAS, there is a desire to maintain an efficient and professional county building department that is self-sufficient through the payment of appropriate and competitive permit fees.

NOW, THEREFORE, BE IT ORDAINED by the Board of Commissioners of Delaware County, that Title 4, Chapter 2 Permit fees shall be amended as follows:

Section 1. That Title 4, Chapter 2 Permit Fees, Section 7 Electrical Permit Fees, Item 2 Commercial and Industrial shall be amended by deleting the existing New Construction provisions which read as follows:

2. New construction:
 - a. 100 AMP and 300 AMP service is \$150.00
 - b. Inspection fee for 400 AMP and up to 1000 AMP is \$175.00
 - c. Inspection fee for 1000 AMP and up is \$200.00 + \$6.00 per 100 sq. ft.;

and by inserting a new provision which reads as follows:

2. New Construction:
 - a. 100 AMP and over is \$175.00 plus \$6.00 per 100 sq. ft.;

and by re-codifying d. and e. to b. and c.

Section 2. That Title 4, Chapter 2 Permit Fees, Section 8 Plumbing Permit Fees, Items 2.a and 2.b under Commercial/Industrial Construction shall be amended by replacing the language “plus \$12.50 per restroom, kitchen, or mechanical room” with “plus \$6.00 per 100 sq. ft.” so that Item 2 reads as follows:

2. Commercial/Industrial Construction:
 - a. New buildings - \$125.00 plus \$6.00 per 100 sq. ft.
 - b. Additions/alterations - \$75.00 plus \$6.00 per 100 sq. ft.

Section 3. That Title 4, Chapter 2 Permit Fees, Section 8 Plumbing Permit Fees, Item 1 Residential Construction shall be supplemented by adding a new Item 1.c which shall read as follows:

1. Residential Construction:



- c. Swimming Pools (in-ground only) - \$65.00

Section 4. That this Ordinance shall be considered in effect upon its adoption and such publication as may be required by law.


