RESOLUTION 24-07

WHEREAS, the Delaware-Muncie Metropolitan Plan Commission (DMMPC) is the Metropolitan Planning Organization (MPO), as designated by the Governor of the State of Indiana, for the Muncie Urbanized Area; and

WHEREAS, the Transportation Policy Committee (TPC) is the policy committee of the Metropolitan Planning Organization involved in the transportation planning process for the Muncie Urbanized Area; and

WHEREAS, the DMMPC staff has prepared a new Metropolitan Transportation Plan (MTP) titled *2023-2050 Delaware-Muncie Metropolitan Transportation Plan: Moving Forward Together* working with local, state, and federal stakeholders – and the public has had the opportunity to provide input, review, and comment on the document through public meetings and a public review period; and

WHEREAS, The MPO consulted with the Interagency Consultation Group and the MPO anticipates, subsequent to Policy Board approval, the USDOT will find that the proposed MTP *2023-2050 Delaware-Muncie Metropolitan Transportation Plan: Moving Forward Together Update* meets transportation conformity requirements under Section 176C of the Clean Air Act and 40 CFR Parts 51.390 and 93; and

WHEREAS, the proposed MTP *2023-2050 Delaware-Muncie Metropolitan Transportation Plan: Moving Forward Together* was presented to the Technical Advisory Committee (TAC) at the December 14, 2023 meeting with no objection; and

WHEREAS, the proposed MTP *2023-2050 Delaware-Muncie Metropolitan Transportation Plan: Moving Forward Together* was reviewed by the Transportation Policy Committee and approved by email vote concluding on January 24, 2024.

NOW, THEREFORE, BE IT RESOLVED by the Transportation Policy Committee of the DMMPCC as follows:

Section 1. That the Delaware-Muncie Metropolitan Plan Commission (DMMPC) approves and adopts the Metropolitan Transportation Plan *2023-2050 Delaware-Muncie Metropolitan Transportation Plan: Moving Forward Together* as the MPO's 20-year Long-Range Transportation Plan.
