RESOLUTION 26-11 REVISED

WHEREAS, the Delaware-Muncie Metropolitan Plan Commission (DMMPC) is the Metropolitan Planning Organization (MPO), as designated by the Governor of the State of Indiana, for the Muncie Urbanized Area; and

WHEREAS, the Transportation Policy Committee (TPC) is the policy committee of the Metropolitan Planning Organization involved in the transportation planning process for the Muncie Urbanized Area; and

WHEREAS, the proposed amendment to the FY 2026-2030 DMTIP to INDOT project DES #2301079, US 35 at CR 300 S (Intersection Improvement, Roundabout), to add FY27 PE in the amounts of \$284,000 Federal HSIP funds and \$31,000 State funds was requested by INDOT; and

WHEREAS, the proposed amendment to the FY 2026-2030 DMTIP to INDOT project DES #2301079 to add FY27 RW in the amounts of \$36,000 Federal HSIP funds and \$4,000 State funds was requested by INDOT; and

WHEREAS, the proposed amendment to the FY 2026-2030 DMTIP to change funding program and increase FY28 CN from \$1,622,044 Federal STBG funds to \$1,825,000 HSIP funds and decrease State funds from \$405,511 to \$203,000 was requested by INDOT; and

WHEREAS, a public input period was held from April 21, 2026 through April 28, 2026 in accordance with DMMPC policy; and

WHEREAS, the proposed amendments above were reviewed and approved by the TPC by e-vote concluding on April 30, 2026.

NOW, THEREFORE, BE IT RESOLVED by the Transportation Policy Committee of the DMMPC as follows:


Section 1. That the FY 2026-2030 DMTIP be amended to add FY27 PE in the amounts of \$284,000 Federal HSIP funds and \$31,000 State funds as shown on Exhibit A.

Section 2. That the FY 2026-2030 DMTIP be amended to add FY27 RW in the amounts of \$36,000 Federal HSIP funds and \$4,000 State funds as shown on Exhibit A.

Section 2. That the FY 2026-2030 DMTIP be amended DMTIP to change funding program and increase FY28 CN from \$1,622,044 Federal STBG funds to \$1,825,000 HSIP funds and decrease State funds from \$405,511 to \$203,000 as shown on Exhibit A.


